



## Terms & Conditions

Should the purchaser not use the vacation package in its entirety within 18 months, the total financial obligation of the purchaser is limited to the vacation package purchase price alone. If the purchaser uses the package in its entirety within 18 months, the purchaser may be subject to the additional charges listed below in sections 1. (a) and 1 (c):

- (a) You understand that you will be responsible for transportation to and from your land destinations, hotel taxes, and any incidentals, such as meals and long-distance telephone calls made from your room. Room deposits are required at some locations. Our booking agent will advise you and you may choose to stay at locations where one is not required (subject to availability). Where required, deposits are held against a major credit card and the funds are released and returned at the end of your stay. Nightly taxes depend on the local state hotel tax and run between \$4-\$16 per nights. Deposits (where applicable) are between \$50-\$200.
- (b) Purchaser has the right to pursue reservations after purchase when providing 30-45 days' notice. You may reschedule your reservation at any time without any charges. Availability is limited to resort capacity and may change at any time, without any notice to Global Fulfillment Services, nor the purchaser.
- (c) You understand that you are eligible for this promotional price in exchange for your time previewing the select host resort. You and your spouse or traveling companion (or the qualified travelers that you transfer this package to) must attend. Failure to attend the presentation will result in a \$99/night fee assessed by GFS and billed to the purchaser after stay is complete.
- (d) Your vacation expires 18 months from your purchase date. ( exp. date ). Once the expiration date has passed, you may call customer service and purchase an 18-month renewal of this package, subject to the same terms and conditions of this purchase. Your package is fully transferable to any adult over the age of 25 and under 70, which means you can give all or portions of this vacation package away as a gift. Simply contact customer service and have a representative notate the name, address and phone number of the individual to whom you would like to transfer all/portions of the vacation package.
- (e) If acceptable to the purchaser, comparable alternate accommodations or facilities in the host city or reservations for a date different than requested may be provided
- (f) This document is a representation of the purchaser's right to use the package as described in this document. It applies only to this single package and no others. There may be up to 8,000 such certificates issued per calendar year. Each certificate expires 18 months after date of purchase. Certificates issued in 2015 will expire no later than 05/31/2017; certificates issued in 2016 will expire no later than 5/31/2018.
